## Terms & Conditions

1. The customer shall pay all rental charges in advance or immediately upon return of the equipment.
2. Rent shall be payable from the time the equipment is delivered to the customer until the time it is returned to Yukon Wide Adventures in acceptable condition.
3. A rental day should be 24 hours and the daily rental rate shall apply to every day.
4. The customer shall also pay rent to Yukon Wide Adventures for each day the rented equipment is in the process of recovery or repair.
5. The customer is fully responsible for all toll charges and any fines or other consequences resulting from violation of Whitehorse Bylaw regulations, or any other laws or regulations during the rental. All fees will be charged to the renter's credit card.
6. The customer shall pay \$ 125 per hour cleaning fee on rented equipment returned unclean.
7. All snowmobile rentals depart with a full tank of gas and oil. They are to be returned with a full tank of gas and proper oil. The customer is responsible for all gas and oil used during usage. Yukon Wide Adventures reserves the right to charge for unfilled fuel and oil.
8. The customer shall be responsible for all damages to or loss of the rented equipment.
9. In the case of damage, the customer shall pay the full cost of all repairs to the equipment, regardless of whether the damage result from accident, neglect, misuse or for any other reason.
10. In the case of loss, the customer shall pay to Yukon Wide Adventures the full replacement costs of the rented equipment.
11. The customer shall indemnify and hold Yukon Wide Adventures harmless from all losses, costs, charges, damages and expenses suffered by the customer in respect of any injury (including death) to any person or damage to any property arising out of the use of the rented equipment by the customer or any other person, firm or corporation during the term of this agreement.
12. Yukon Wide Adventures may terminate this agreement at any time and demand return of the rented equipment and payment in full of all rental charges owing to date.
13. In case of failure of the rented equipment, the customer shall immediately notify Yukon Wide Adventures; otherwise, no adjustment of the rental charges will be considered.
14. The provisions of this agreement, including these terms and conditions, constitute the entire agreement between Yukon Wide Adventures and the customer and there are no representations or warranties, express or implied, statutory or otherwise, and no agreements collateral hereto other than as expressly set forth herein.
15. The customer authorizes Yukon Wide Adventures to charge the customers credit card for rental charges and damages done to the rented equipment.
